## DESIGN

### CONSTRUCTIVE DESIGN

All the materials used correspond to the requirements according to RAL-GZ 430/3

Single chair, metal base frame, form foam

Seat upholstery structur: form foam, Diolen

Back upholstery structure: form foam, Diolen

### UPHOLSTERY FIRM

With a firm upholstery you do not sink very deep into the upholstery but sit „on the sofa“. The ridge of covers is avoided extensively by constructive measures (among others prestressed upholstery). Drawings e.g. at curves, gathers are according to the construction or the design.

### BACK TENSIONING SECTIONS

All back tensioning sections are supplied as standard with the original cover.

## COMBINATION OF COVERING MATERIALS


If desired two different covering materials can be combined with this model.

Here must be indicated the respectively desired covering material with cover part 1 and cover part 2.

With combination of two covering materials of a different price the higher price category will be invoiced as standard.

Fabric- and leather requirement of each cover part on request.

 cover part 1: seat, back and armrest

 cover part 2: seat-, back and armrest tensioning section

## LEGS

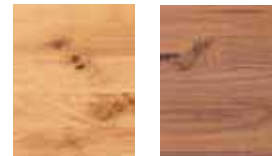
### AR chair SAVX

Solid wooden leg (UV laminated with oil effect) optionally available in:

- wild oak natural
- walnut



from the left to the right:



### AR chair SASX

Metal leg available in:

- structural black mat



### AR chari SAYX

Metal leg chamfered available in:

- structural black mat



**Please note:** With all chairs the seat is rotatable by 320°.



**AR chair SAVX:** In addition the seat of the chair SAVX has an automatic return. Here the seat returns self-acting into the basic position on standing up.

## SEAM

Depending on the model, the seam on leather covers may be different from fabric covers, especially on fitted items. Decorative leather seam (as double lapped felling or double seams) may be omitted depending on the model according to suitability of the fabric covering material.

This model is only worked with selvedge seam.

## CONTRAST STITCHING

The production is carried out either **with contrast stitching** or with a **thread (tone on tone)** matching the leather in terms of colour.

### CONTRAST STITCHING

With leather covers and with fabric-leather-combinations a **contrast thread colour** must be explicitly chosen.

With bicoloured covers the thread colour will be worked on the front and on the rear side.

Unfortunately with fabric and microfiber covers without leather part a processing with contrast stitching is not possible.

### Exception fabric 13-BISON:

These fabric can be produced with contrast stitching. A contrast thread colour must be explicitly chosen.

### THREAD TONE ON TONE

The model is worked with a thread matching the cover in terms of colour (tone on tone).

With bicoloured covers and with fabric-leather-combinations the matching thread will be automatically worked on the front and on the rear side.

## COVERING MATERIALS

Alternative covers of the wide upholstery covering material collection (**exception N-NATURO**) are possible as custom-made product. Therefore an extra charge of all in 20% is valid for fabric and leather.
