DESIGN

CONSTRUCTIVE DESIGN

All the materials used correspond to the requirements according to RAL-GZ 430/3

Fully upholstered bench, wooden base frame

Seat upholstery structure: zig-zag springs, Dacron, polystyrene foam VW 50, Diolen

Back upholstery structure: rubber straps, polystyrene foam, Diolen

UPHOLSTERY CASUAL / LOOSE

With casual upholsteries you are rather sitting "in the sofa" than on it, the upholstery snuggles. A casual/loose upholstery is characterized by a smooth upholstery structure. The cover is not waveless. The ridge of the covers on the seat, back and the armrests as well as sitzmarks due to model and design are typical.

Slight differences in seat firmness with add-on groups are according to construction and therefore constitute no grounds for complaint.

BACK TENSIONING SECTIONS

All back tensioning sections are supplied as standard with the original cover.

LEGS

Solid wooden leg, UV laminated with oil effect, optionally available in:

- beech
- wild oak natural
- wild oak bianco
- walnut (against extra charge see price sheet)

or

- wild oak black stained (lacquered)

from the left to the right:











COMBINATION OF COVERING MATERIALS

If desired with this model two different covers can be combined.

Here must be indicated the respectively desired covering material with cover part 1 and cover part 2.

With combination of fabric and leather the leather price will be invoiced as standard.

Fabric- and leather requirement of each cover part on request.

cover part 1: seat and back

cover part 2: seat- and back tensioning section





CHAIR

With this model we recommend the suitable chair 1202.



SEAM

Depending on the model, the seam on leather covers may be different from fabric covers, especially on fitted items. Decorative leather seam (as double lapped felling or double seams) may be omitted depending on the model according to suitability of the fabric covering material.

This model is only worked with selvedge seam.

COVERING MATERIALS

You may find the information concerning the specific properties of the covering materials on the sample labels.

Alternative covers of the wide upholstery covering material collection **(exception N-NATURO)** are possible as custom-made product. Therefor an extra charge of all in 20% is valid for fabric and leather.

CONTRAST STITCHING

The production is carried out either **with contrast stitching** or with a **thread (tone on tone)** matching the leather in terms of colour.

CONTRAST STITCHING

With leather covers and with fabric-leather-combinations **a contrast thread colour** must be explicitly chosen.

With bicoloured covers the thread colour will be worked on the front and on the rear side.

Unfortunatley with fabric and microfiber covers without leather part a processing with contrast stitching is not possible.

Exception fabrics 13-BISON, 13-CHASE and 13-TORRERO:

These fabrics can be produced with contrast stitching. A contrast thread colour must be explicitly chosen.

THREAD TONE ON TONE

The model is worked with a thread matching the cover in terms of colour (tone on tone).

With bicoloured covers and with fabric-leather-combinations the matching thread will be automatically worked on the front and on the rear side.



INDICATIONS OF DIMENSIONS AND REQUIREMENTS

All the values given are approximate values: dimensions in centimetres, material requirements in metres, leather requirements in square metres.


ORDER CHECK LIST

Please pay attention to the following issues respectively to complete indications when ordering:

- combination
- covering material, with combination of covering materials covering material per cover part (in general N-NATURO is not possible)
- with leather covers and fabric-leather-combination production with or without contrast stitching
- with version with contrast stitching colour of contrast thread
- finish of solid wooden legs




